121 York Road – 10/02330/LA – 30.6.2010. Replacement of 3 no. wooden casement windows to the rear (top floor) with 3 no. wooden casement windows of a similar design. Paint rear of property light green. No comment required.

138, 140 - 142 Cheltenham Road (proposed Tesco) - 10/02337/A,10/02338/F,10/02732/F - 7.7.2010. Installation of illuminated and nonilluminated signage. External alterations to shop front including installation of an ATM. Installation of plant and machinery, screening wall and external alterations to rear service yard. No comment required.
