County House, 1-3 Surrey Street, St Pauls – 13/05714/COU – 15.12.2013. Notification of a proposed change of use whereby the ground and upper floors are converted into private residential accommodation, whilst the basement will provide parking spaces, cycle and refuge storage. (Class B1a to Class C3). No comment.

23A Sussex Place – 13/05841/FB – 22.12.2013. Window replacement to the whole of 23 Sussex Place. Letter to comment on the inappropriate use of uPVC.

138 City Road, St Pauls – 13/02832/F – 12.1.2014. Change of use from two flats and one maisonette to four flats with a 3-storey extension to existing 4-storey building. No comment.

11 Ashley Road – 14/00055/VC – 19.1.2014. T1 Lilac & T2 Pear: fell to ground level, outgrown situation and growing over neighbour's wall. T3 Sycamore: fell to ground, too close to boundary and blocking light. T4 Mixed hedge & T5 Sycamore: fell to ground level. T6 Birch & T7 & T8 Plum: reduce crown by approximately 20%. Letter requesting replacements to be planted.

 $59 \ Cobourg \ Road - 14/00176/VC - 19.1.2014$. Fell and remove a large Magnolia in the front courtyard of property. No comment.
