42 Upper Cheltenham Place – 16/02690/H – 22.5.2016. Small refurbishment of conservatory including raising the eaves, new flat roof, adding new doors, wall cladding and a skylight. No comment.

131 Ashley Road - 16/02642/VC - 22.5.2016. Conifer - Fell. No comment.

20 Richmond Road – 16/02387/H – 22.5.2016. Installation of balcony to the rear of the property. No comment.

2 Old Ashley Hill - 16/02832/H - 29.5.2016. Application for new off-street parking with new garage door access, and rebuilding of shed below car park space. Reinstatement of original features on south, including windows, doors, conservatory, balustrade on top of tower. Re-building of lean-to porch. No comment.
