Part demolition of existing Criterion Public House (Use Class A4) with retention of facade and construction of 4 storey building to provide 7 No. self-contained flats (6 x 2 bedroom and 1 x 1 bedroom) with retail unit (A1) on the ground floor and associated storage at basement level. Letter of objection.

104 York Road – 19/04137/VC – 25.8.2019. T1 – Elder – Fell. Replace with Holly positioned further away from the wall. No comment.

7 Old Ashley Hill – 19/03809/H - 1.9.2019. Retention of rear 'dormer' roof extension. Letter of objection and comment.

35-37 Stokes Croft – 19/04247/Z – 1.9.2019. Enforcement notice appeal for the installation of external roller shutters and associated shutter housing structures to the front of the property. Submission to appeal, supporting enforcement complaint.

Seven Ways Service Station, Sussex Place – 19/04261/COND – 1.9.2019. *Montpelier Railway Station, Station Road* – 19/04311/VC – 8.9.2019. Crown lift all trees (various species) adjacent station associated pedestrian walkways and access to 3m from ground level to enable safe access for uses by removing encroaching branches within walkways/access. Crown lifting will only be required on the aspect of the trees that is directly adjacent walkway/access. Where branches over extend into platform areas raised walkways reduction of branches may be required by pruning bracken back by 1-2 m in length to maintain clear access. No comment.

*112 and 114 St Andrews Road* – 19/04396/COND – 15.9.2019. Application to approve details reserved by condition nos 2 (Further details), 3 (PV Panels), 4 (Implem/install refuse/recycling) and 5 (Complete/ maintain cycle provision) attached to 17/05877/F, which approved the demolition of 2 garages and erection of 2 dwelling houses. *[nb application not open for comments – included for information only]*
